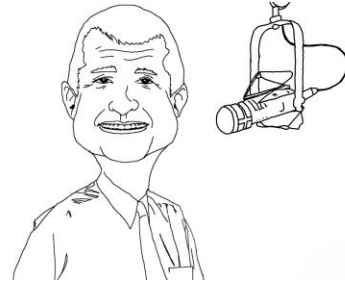

SONGS TO GO DJ SERVICE HEREBY AGREES TO PROVIDE A DJ SERVICE FOR THE ABOVE MENTIONED DATE(S) AND LOCATION. SONGS TO GO DJ SERVICES WILL NOT BE HELD RESPONSIBLE FOR ANY MUSIC OR LICENSEE FEES. SONGS TO GO DJ SERVICES WILL NOT BE HELD RESPONSIBLE FOR ANY PERSONAL INJURIES OCCURRING TO ANY PERSON ATTENDING THE EVENT. SONGS TO GO DJ SERVICE WILL NOT BE HELD RESPONSIBLE FOR ANY DAMAGES TO THE FACILITIES AT THE EVENT SITE.

*A \$100 DEPOSIT IS REQUIRED UPON VERBAL AGREEMENT. DEPOSITS ARE NON-REFUNDABLE AND SERVE TO LOCK THE DATE FOR YOUR EVENT SO THAT SONGS TO GO DJ SERVICE AND VIDEOGRAPHY DOES NOT BOOK ANY WORK THAT WOULD CONFLICT WITH MY INVOLVEMENT IN YOUR EVENT.

IF ANY EMPLOYEE OF SONGS TO GO DJ SERVICE IS HARASSED, THREATENED, OR ASSAULTED BEFORE OR DURING THE EVENT, SONGS TO GO DJ SERVICE HAS THE RIGHT TO IMMEDIATELY TERMINATE THE CONTRACT AND END THE ACTIVITIES FOR THAT EVENT.

IT IS HEREBY FURTHER AGREED; THAT THE PURCHASER SHALL BE HELD LIABLE FOR ANY INJURY OR DAMAGES TO THE DJ, OR PROPERTY OF THE DJ, WHILE ON THE PREMISES OF SAID ENGAGEMENT, IF DAMAGE IS CAUSED BY PURCHASER OR GUEST, MEMBERS OF HIS ORGANIZATION, ENGAGEMENT INVITEES, EMPLOYEES, OR ANY OTHER PARTY IN ATTENDANCE, WHETHER INVITED OR NOT.

REQUIREMENTS

ONE GROUNDED AC OUTLET MUST BE PROVIDED FOR SOUND SYSTEM. THIS OUTLET MUST BE GROUNDED AND BE WIRED ACCORDING TO CODE TO PREVENT DAMAGE TO SONGS TO GO DJ SERVICES EQUIPMENT. OWNER OF EVENT SITE WILL BE HELD RESPONSIBLE FOR ANY DAMAGE DONE TO SONGS TO GO DJ SERVICES EQUIPMENT DUE TO ELECTRICAL CONDITIONS AND / OR ELECTRICAL PROBLEMS THAT DO NOT MEET CURRENT ELECTRICAL CODES. MOST ESTABLISHMENTS EASILY MEET THESE REQUIREMENTS.
